### **Interdisciplinary Conference on the 650<sup>th</sup> Anniversary of the Anglo-Portuguese Alliance: Tacking Stock of the Past and Envisioning the Future**

6-9 July 2022,

University of Minho, Braga, Portugal

Paper/sessions submission deadline: **15 January 2022**

Decisions: by **31 January 2022**

The Interdisciplinary Conference on the 650<sup>th</sup> anniversary of the 1372 Treaty of Tagilde, which is considered the precursor of the Anglo-Portuguese alliance, seeks to contribute to a better understanding of the rich history of the oldest diplomatic alliance still in force. It marks the Alliance's anniversary with a creative space for dialogue and interchange of knowledge between researchers with very different backgrounds. The encounter should bring about a deeper understanding of the Anglo-Portuguese alliance past and present, and envisage its possible future reverberations in a context marked by the exit of the United Kingdom from the European Union.

This Conference is part of the programme of events to mark the 650<sup>th</sup> anniversary of the Anglo-Portuguese alliance in Portugal and the United Kingdom, joining the *Portugal-UK 650* initiative.

#### **PAPER SUBMISSION**

The organisers welcome panels and individual papers that fall under the following topics:

- The antecedents of the Anglo-Portuguese alliance
- The beginnings of the Anglo-Portuguese alliance
- The Anglo-Portuguese treaties: formal and material content; historical context
- The Anglo-Portuguese alliance and Empires
- The Anglo-Portuguese alliance as agent of cultural, legal, political, economic and intellectual interchanges

- Actors who stood out in the design of the Anglo-Portuguese relations and/or functioned as agents of cultural, legal, political, economic and intellectual interchanges: statesmen, diplomatic representatives, drafters, royal counsellors, merchants, royal consorts, artists, maecenas, men of culture, etc.
- The Anglo-Portuguese military alliance
- The Anglo-Portuguese diplomatic alliance
- The Anglo-Portuguese commercial alliance
- The Anglo-Portuguese alliance and Religion
- The Anglo-Portuguese alliance and Education
- The Anglo-Portuguese alliance and Tourism
- The Anglo-Portuguese in the global context:
  - a) the Anglo-Portuguese alliance compared to others alliances
  - b) repercussions of the Anglo-Portuguese alliance in the European/global history
  - c) the contribution of the Anglo-Portuguese alliance to the development of international relations and international law
  - d) the Anglo-Portuguese alliance in the multilateral world
- The Anglo-Portuguese alliance in the world post-Brexit:
  - a) repercussions for the political, economic, cultural and military relations between Portugal and the UK;
  - b) repercussions for Migration law, Family and Succession law, Commercial and Corporate law, Procedural law, Private International law, Penal law, Diplomatic and Consular law, Public International law and International Relations, European Union law, Tax law, International Economic and Customs law

We are, however, open to other variations on the general theme.

**Please note the following rules:**

Abstracts for individual papers should not exceed 500 words. Co-authored papers are acceptable.

Additionally, panel proposals (max. 3 papers for panel) should also be accompanied by an abstract of up to 300 words on the general theme of the panel, explaining how the papers are interconnected. The latter is to be submitted by the panel leader.

Together with the regular papers and panels, the Conference also provides a Junior Session for postgraduate students.

The working languages of the conference are Portuguese and English.
